**Restructuring of the German part of the Vink Group  
Transfer of suppliers relations from König GmbH Kunststoffprodukte to Vink  
Kunststoffe GmbH  
(in future renaming as Vink König Deutschland GmbH)**

Dear Business Partners

As long-standing and reliable business partners, we would like to inform you about the restructuring of the German Vink Group:

König GmbH Kunststoffprodukte will be merged with Vink Kunststoffe GmbH during 2021 in accordance with German law.

This merger of König GmbH Kunststoffprodukte will become legally effective with the entry in the German Commercial Register, which is planned for August 2021. The legal consequence of such a merger is a so-called universal succession, i.e. all rights and obligations as well as all assets and liabilities of König Kunststoffprodukte GmbH are automatically transferred to Vink Kunststoffe GmbH.

From an economic point of view, the merger will take effect retroactively as of January 1st 2021 and all business of König Kunststoffprodukte GmbH transferred by the merger will be deemed to be for the account of Vink Kunststoffe GmbH. This also applies to any contractual relationship with you. As a result of the merger, all existing contracts between you and König GmbH Kunststoffprodukte are transferred to Vink Kunststoffe GmbH with retroactive economic effect as of January 1st 2021.

Since the merger of König Kunststoffprodukte GmbH and its retroactive economic consequences will only become legally effective upon entry in the German Commercial Register, there is a transitional period beginning January 1st 2021 until the merger is entered in the German Commercial Register, which the two companies will bridge by means of a company lease agreement.

As part of the operating lease agreement, König Kunststoffprodukte GmbH transfers all existing contractual relationships to Vink Kunststoffe GmbH, among other things. Orders and invoices shall be placed/issued exclusively by Vink Kunststoffe GmbH from this point in time or shall be addressed to Vink Kunststoffe GmbH from this point in time.

We assume that you agree to such a transfer of the contractual relationships existing with you to Vink Kunststoffe GmbH . If you have any questions or objections in this regard, please let us know by December 31th 2020.

Furthermore, the company Vink Kunststoffe GmbH will be renamed (presumably January 1 st 2021) **as Vink König Deutschland GmbH**. In this context, we ask you to adapt your master data to **Vink König Deutschland GmbH** as of January 1, 2021.

Your contact persons and their contact data will of course remain unchanged. You can contact us at any time.

We would like to take this opportunity to thank you for the trust you have placed in us to date and look forward to continuing our good cooperation with you.
